Twenty-Sixth Annual Conference Oakland University Rochester, Michigan May 8-9, 2015

CALL FOR PAPERS

SUBMISSION DEADLINE: Thursday, January 15, 2015

This year's conference marks the twenty-fifth anniversary of Music Theory Midwest. As part of the celebration, the conference will feature a keynote address by Professor Richard Cohn titled, "Why We Don't Teach Meter, and Why We Should." Our choice of Prof. Cohn as keynote speaker comes from the desire to celebrate crucial developments in our field that originated or were significantly extended in the Midwestern region. Prof. Cohn was a member of the original MTMW organizing committee, and his work has made a huge impact on the field, both directly and through his students. In particular, the society wishes to acknowledge how Prof. Cohn cultivated neo-Riemannian theory by publically engaging with students and interested faculty at MTMW meetings. For example, Prof. Cohn's 1994 MTMW keynote address in Bloomington may have been the first public presentation on what became neo-Riemannian theory.

Our fifth annual pre-conference workshop, titled "Early-Career Publishing," will be led by Karen Bottge, Jeremy Day-O'Connell, Patricia Hall, and Yayoi Uno-Everett (see p. 4 of the newsletter for more details).

Music Theory Midwest invites scholars from all geographic regions to submit proposals on any area of music theory and analysis for our annual conference.

As is traditional at MTMW, we encourage proposals on composers, musicians, and events with significant anniversaries in 2015, and we welcome proposals for special sessions devoted to these or any other particular topic.

PROPOSAL INSTRUCTIONS AND GUIDELINES

INDIVIDUAL PRESENTATIONS: Papers should not have been previously presented at national or international conferences nor previously published. Only one proposal per submitter will be considered. Papers should be planned for presentation in twenty minutes followed by ten minutes for questions. In some cases the program committee may recommend that a proposal be presented as a poster. Submitters may indicate a preference to present their work in a poster session.

Proposals should be submitted electronically via the MTMW website at http://www.mtmw.org/index.php/conferences. Submissions are due no later than January 15, 2015. The online form serves as the cover letter, while the proposal and any supplemental materials are to be submitted as a single document in .pdf format. The proposal should not exceed 500 words, including any footnotes or endnotes but not including the title. A maximum of four pages of supplementary materials (such as musical examples, diagrams, and bibliography) may be appended, and are excluded from the word count, but these materials should not appreciably add to the proposal's content. The proposal must include the title of the paper but exclude the author's name

SPECIAL SESSIONS: Proposals for Special Sessions have no specific page limit and should include the names of the organizer and all participants. Special sessions should be organized in a way such that the program committee could not create from separately submitted individual proposals. Anyone wishing to propose a special session should contact the program chair (Ryan McClelland, ryan.mcclelland@utoronto.ca) well in advance of the proposal deadline.

KOMAR AWARD: The Arthur J. Komar Award for best student paper will be presented at the conclusion of the meeting. Student presenters who wish to be considered for this award must indicate this in the online submission form. For the purposes of this award, "student" status terminates with the receipt of a terminal degree or employment in a full-time position. NOTIFICATION: Those submitting proposals will receive notification of the program committee's decision by early March.

PRE-CONFERENCE WORKSHOP

Music Theory Midwest is pleased to announce its fifth annual Pre-Conference Workshop, "Early-Career Publishing," led by Karen Bottge (University of Kentucky), Jeremy Day-O'Connell (Knox College), Patricia Hall (University of Michigan), and Yayoi Uno-Everett (University of Illinois at Chicago). MTMW pre-conference workshops are open to both students and faculty. This year's workshop will be held on the campus of Oakland University in Rochester Hills, MI, from 6:00 to 9:00 p.m. on Thursday, May 7, 2015, immediately prior to the annual meeting on Friday and Saturday, May 8–9. Details of the workshop are given below.

WORKSHOP TITLE: "Early-Career Publishing"

DESCRIPTION: A panel of distinguished scholars with ample experience in the area of publication will lead this interactive professional-development workshop outlining the process leading to publication and offering suggestions to meet the associated challenges.

The most common publication formats within our field and two key topics will be addressed:

- a. From conference paper to publication
- b. Publishing in journals
- c. Publishing monographs
- d. Publishing in edited collections
- e. The review process
- f. Obtaining funding for research leading to publication

ELIGIBILITY: All interested faculty and graduate students are encouraged to apply following the instructions below. Participants are not required to reside in the Midwest region. The workshop will be limited to 10 participants.

APPLICATION PROCEDURES:

Faculty: Send an email indicating your interest in the workshop to Melissa Hoag, MTMW Secretary, at hoag@oakland.edu. Include your name, institutional affiliation, academic status, mailing address, email address, and telephone number. Faculty participants will be selected randomly from those who have applied.

Students: Submit a statement of no more than 500 words, in .pdf, .docx, or .doc format, describing your background and the reasons for your interest in this workshop. Your statement should indicate your institutional affiliation and your academic status, but should not include your name, as the statements will be read blind. Submit the statement as an email attachment to Melissa Hoag, MTMW Secretary, at hoag@oakland.edu. In the body of the email, include your name, institutional affiliation, academic status, mailing address, email address, and telephone number. The workshop leaders will select the student participants after reading the statements.

APPLICATION DEADLINE: January 15, 2015. Workshop applicants can expect to receive notification of acceptance decisions by mid-February.

Qualified nominees should be music theorists who teach or are otherwise engaged in theory studies in the Midwest United States, or appropriate regions in Canada. Student representatives should be engaged in graduate studies and should expect to continue their student status for at least one year after taking office. Students may not serve as officers or area representatives. All officers of the Executive Committee are expected to attend plenary sessions and the business meeting at the annual conference.
